1. Engagement and Scope of Work

Client hereby engages Artist to provide the artwork described herein (the “Work”) under the terms of this Agreement, and Artist accepts such engagement. The Work shall be completed in accordance with the specifications, timeline, and milestones agreed upon by the parties.

2. Compensation

Client agrees to pay Artist a total fee of \$_____. Payment shall be made according to the following schedule: a deposit of \$_____ upon execution of this Agreement, with the balance due upon delivery of the final Work. All payments shall be made in U.S. Dollars.

3. Delivery and Acceptance

Artist shall deliver the completed Work to Client in the agreed format by the agreed deadline. Client shall have ____ days after delivery to review and approve the Work or request reasonable revisions. Failure to respond within this period shall constitute acceptance.

4. Intellectual Property Rights

Artist retains all copyrights and moral rights in the Work, subject to the following license granted to Client: a non-exclusive, worldwide, perpetual license to use, reproduce, and display the Work for the purposes agreed herein. Client shall not modify the Work without Artist’s prior written consent.

5. Revisions

Client is entitled to ____ rounds of revisions included in the fee. Additional revisions shall be billed at \$_____ per hour. Revisions requested that materially alter the scope or nature of the Work may require a separate agreement.

6. Warranties and Representations

Artist represents and warrants that the Work is original and does not infringe upon any copyright, trademark, or other rights of third parties. Client represents that any materials provided to Artist do not infringe any third-party rights and that Client has full rights to use all materials provided.

7. Confidentiality

Both parties agree to keep confidential any proprietary or sensitive information disclosed during the course of this Agreement, except as required by law or mutually agreed upon in writing.

8. Indemnification

Each party agrees to indemnify, defend, and hold harmless the other party from any claims, damages, liabilities, costs, or expenses arising out of any breach of this Agreement or violation of applicable laws.

9. Termination

Either party may terminate this Agreement upon written notice if the other party breaches any material term and fails to cure within ____ days. Upon termination, Client shall pay Artist for all Work performed up to the date of termination.

10. Independent Contractor

Artist is an independent contractor and not an employee, agent, or partner of Client. Artist shall be solely responsible for all taxes, insurance, and other obligations arising from the compensation received under this Agreement.

11. Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

12. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, and agreements, whether written or oral, relating to the subject matter hereof. Any amendments or modifications must be in writing and signed by both parties.

13. Severability

If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect.

14. Notices

All notices under this Agreement shall be in writing and shall be deemed given when delivered by hand, certified mail (return receipt requested), nationally recognized overnight courier, or email (with confirmation of receipt), to the

addresses set forth above or to such other addresses as designated by notice.
