Section 1 – Purpose of Agreement

This Agreement is intended to set forth the terms and conditions under which the Non-Custodial Parent will provide financial support for the child(ren) named herein, in accordance with applicable United States laws and guidelines.

Section 2 – Payment Terms

The Non-Custodial Parent agrees to pay the Custodial Parent the Support Amount as specified above, on the agreed Payment Frequency and by the designated Payment Method. Payments shall commence as agreed by the parties and continue until the child(ren) reach the age of majority or as otherwise required by law.

Section 3 – Healthcare and Medical Expenses

The parties agree that healthcare and medical expenses not covered by insurance shall be shared as follows: _____ . Each party shall provide notice and documentation of such expenses.

Section 4 – Education Expenses

Additional education expenses, including but not limited to tuition, books, and extracurricular activities, shall be the responsibility of: _____ . Any such expenses require prior written consent.

Section 5 – Childcare Expenses

Childcare expenses shall be allocated between the parties as follows: _____. Receipts and documentation shall be provided upon request.

Section 6 – Taxes

The parties agree to cooperate in claiming any tax benefits, exemptions, or credits related to the child(ren) in accordance with applicable tax laws and regulations.

Section 7 – Modification

This Agreement may be modified only by a written document signed by both parties or by a court order. Changes in circumstances affecting support obligations shall be promptly communicated.

Section 8 – Enforcement

This Agreement is enforceable under the laws of the relevant State. Failure to comply with the terms may result in enforcement actions, including but not limited to wage garnishment, contempt proceedings, or other remedies.

Section 9 – Termination

The obligations under this Agreement shall terminate when the child(ren) reach the age of majority, become emancipated, or as otherwise provided by applicable law or court order.

Section 10 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. The parties consent to venue and jurisdiction in the appropriate courts located within _____ County, _____.

Section 11 – Entire Agreement

This Agreement contains the entire understanding between the parties concerning child support and supersedes all prior negotiations, representations, or agreements, whether written or oral.

Section 12 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Section 13 – Notices

All notices required or permitted under this Agreement shall be in writing and shall be delivered personally, by certified mail, or by recognized overnight courier to the addresses set forth above or as otherwise designated in writing.

Section 14 – Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one agreement.

Section 15 – Acknowledgment

Each party acknowledges that they have read and understood this Agreement, have had the opportunity to seek independent legal advice, and enter into this Agreement voluntarily and without duress.
