

DISPUTE RESOLUTION AGREEMENT

This Dispute Resolution Agreement (the "Agreement") is entered into by and between:

Recitals:

WHEREAS, disputes may arise between the Parties relating to or arising out of their agreements, transactions, or relationship (the "Dispute" or collectively, "Disputes"); and WHEREAS, the Parties wish to resolve any such Disputes promptly, fairly, and without recourse to litigation.

1. Scope of Agreement

This Agreement governs all disputes, claims, or controversies arising out of or relating to the Parties' agreements, transactions, or relationship, whether arising before or after the execution of this Agreement.

2. Informal Negotiation

The Parties agree to first attempt in good faith to resolve any Dispute by informal negotiation within thirty (30) calendar days of written notice of such Dispute by either Party.

3. Mediation

If negotiation fails, the Parties agree to submit the Dispute to mediation administered by a mutually agreed-upon mediator or mediation service. The mediation shall be conducted in accordance with the applicable rules and procedures of the chosen mediation entity. Each Party shall bear its own costs and an equal share of the mediation fees.

4. Arbitration

If the Dispute is not resolved through mediation within sixty (60) calendar days following the mediation request, the Parties agree to resolve the Dispute exclusively by binding arbitration administered by the American Arbitration Association (AAA) under its Commercial Arbitration Rules, or another mutually agreed arbitration provider.

The arbitration shall be conducted by a single arbitrator with substantial experience in the subject matter of the Dispute. The place of arbitration shall be a mutually agreed location within the United States.

5. Arbitrator's Authority and Decision

The arbitrator shall have the authority to grant any remedy or relief that the arbitrator deems just and equitable and within the scope of the Parties' agreement, including injunctive relief, specific performance, and attorneys' fees if provided by law.

6. Confidentiality

All negotiations, mediation, arbitration proceedings, and outcomes shall be maintained as confidential by the Parties and the arbitrator, except as required by law or to enforce any arbitration award.

7. No Class Actions

The Parties waive any right to participate in any class action or representative proceeding relating to any Dispute, whether in arbitration, court, or otherwise.

8. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles.

9. Enforcement and Judgment

Any arbitration award may be entered as a judgment in any court having jurisdiction. The Parties consent to the exclusive jurisdiction of such courts for purposes of enforcement.

10. Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect and shall be enforced to the fullest extent permitted by law.

11. Entire Agreement

This Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral.

12. Amendments

No modification or waiver of any provision of this Agreement shall be effective unless in writing and signed by both Parties.

13. Waiver

The failure of either Party to enforce any provision of this Agreement shall not constitute a waiver of future enforcement of that or any other provision.

14. Counterparts and Electronic Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together constitute one agreement. Electronic signatures shall have the same force and effect as original signatures.
