Recitals:

WHEREAS, Service Provider is engaged in providing professional management services; and WHEREAS, Client desires to retain Service Provider to perform such services under the terms and conditions set forth herein.

1. Services:

Service Provider shall provide management services as described in Schedule A attached hereto and incorporated herein by this reference. Service Provider agrees to perform such services diligently and to the best of its abilities.

2. Term and Termination:

This Agreement shall commence on the effective date and continue until terminated by either party upon thirty (30) days written notice. Termination for cause may be immediate upon material breach by either party, subject to cure within fifteen (15) days of notice.

3. Compensation:

Client shall pay Service Provider the fees set forth in Schedule B attached hereto. Payments shall be made within thirty (30) days of invoice receipt. Late payments shall bear interest at 1.5% per month.

4. Independent Contractor:

Service Provider is an independent contractor and not an employee, agent, or partner of Client. Service Provider shall have no authority to bind Client or incur obligations on Client's behalf except as expressly authorized in writing.

5. Confidentiality:

Each party agrees to keep confidential all non-public business information obtained from the other party. This obligation shall survive termination of this Agreement.

6. Indemnification:

Each party shall indemnify, defend, and hold harmless the other party from any claims, damages, liabilities, costs, and expenses arising from breach of this Agreement or negligence.

7. Limitation of Liability:

Neither party shall be liable for incidental, consequential, punitive, or special damages arising out of or related to this Agreement, regardless of cause.

8. Governing Law and Venue:

This Agreement shall be governed by and construed under the laws of the State of _____ without regard to conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

9. Notices:

All notices under this Agreement shall be in writing and shall be deemed given when delivered personally, sent by nationally recognized overnight courier, certified mail return receipt requested, or electronic means capable of confirming transmission and receipt to the addresses set forth above or as otherwise designated.

10. Severability:

If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect, and such invalid provision shall be replaced by a valid one that most closely reflects the parties' intent.

11. Entire Agreement:

This Agreement, including all Schedules and attachments, constitutes the entire agreement between the parties and supersedes all prior agreements or understandings, whether written or oral. Amendments must be in writing and signed by both parties.

12. Counterparts and Electronic Signatures:

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Signatures transmitted electronically (e.g., PDF or facsimile) shall be deemed original signatures.
