Recitals:

WHEREAS, Mentor has expertise, knowledge, and experience in the relevant field and desires to provide mentoring services to Mentee; WHEREAS, Mentee desires to obtain mentoring services from Mentor under the terms and conditions set forth herein.

1. Purpose:

The purpose of this Agreement is to establish the terms under which Mentor will provide mentoring services to Mentee to support Mentee's personal and professional development.

2. Mentoring Services:

Mentor agrees to provide mentoring services including guidance, advice, and support to Mentee. Such services may include regular meetings, telephone or video consultations, and review of materials related to Mentee's development.

3. Term and Termination:

This Agreement shall commence on the Effective Date and continue until terminated by either party upon written notice. Either party may terminate this Agreement at any time for any reason upon providing written notice to the other party.

4. Confidentiality:

Both parties agree to maintain in confidence all confidential information disclosed during the mentoring relationship. Confidential information shall not include information that is publicly known or becomes publicly known through no fault of the receiving party.

5. No Warranty; No Guarantee:

Mentor makes no warranties or guarantees regarding the results of the mentoring services. Mentoring services are provided 'as is' and Mentor shall not be liable for any decisions or actions taken by Mentee.

6. Independent Contractor Relationship:

Mentor and Mentee acknowledge and agree that Mentor is acting as an independent contractor and not as an employee or agent of Mentee.

7. Limitation of Liability:

Mentor's total liability to Mentee under this Agreement shall be limited to direct damages and shall not exceed any fees paid by Mentee to Mentor. In no event shall Mentor be liable for consequential, incidental, special, or punitive damages.

8. Indemnification:

Mentee agrees to indemnify, defend, and hold harmless Mentor from and against any claims, liabilities, damages, and expenses arising out of or related to Mentee's actions or omissions.

9. Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict-of-law rules. The parties consent to the exclusive jurisdiction of state and federal courts located in _____ County, _____.

10. Entire Agreement; Amendments:
