Recitals:

WHEREAS, the Parties desire to enter into an open relationship agreement to define their mutual rights, responsibilities, and expectations, recognizing the nature of their relationship is non-monogamous and consensual; and WHEREAS, the Parties intend for this Agreement to be legally binding and enforceable under United States law;

Section 1 – Definitions

For purposes of this Agreement, the following terms shall have the meanings set forth below: “Open Relationship” means a consensual relationship in which the Parties agree to engage with other individuals romantically and/or sexually, subject to the terms herein.

Section 2 – Relationship Status

The Parties acknowledge and agree that they are in a committed relationship but agree that neither Party is exclusively monogamous unless otherwise agreed in writing.

Section 3 – Communication and Consent

The Parties agree to maintain open, honest, and respectful communication regarding all aspects of the relationship, including but not limited to new partners, boundaries, and concerns. Consent is required for all new activities or partners.

Section 4 – Boundaries and Agreements

The Parties agree to the following boundaries and rules regarding outside relationships: 1) Safe sex practices must be adhered to at all times. 2) Disclosure of new partners shall be made promptly. 3) Emotional and physical health shall be prioritized. Any exceptions or additional rules shall be documented separately and signed by both Parties.

Section 5 – Privacy and Confidentiality

The Parties agree to respect each other's privacy and keep all personal information, including details about third parties, confidential unless otherwise agreed.

Section 6 – Conflict Resolution

In the event of disagreements or disputes arising from this Agreement or the relationship, the Parties agree to attempt resolution through good-faith discussion, and if necessary, seek mediation or counseling.

Section 7 – Term and Termination

This Agreement shall remain in effect until terminated by mutual written consent or by either Party providing written notice to the other. Termination of this Agreement shall not affect any rights or obligations accrued prior to termination.

Section 8 – No Waiver of Rights

Failure to enforce any provision of this Agreement shall not constitute a waiver of any rights hereunder.

Section 9 – Governing Law; Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. The Parties consent to the exclusive jurisdiction and venue of the state or federal courts located in _____ County, _____.

Section 10 – Severability

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

Section 11 – Entire Agreement

This Agreement constitutes the entire agreement between the Parties related to its subject matter and supersedes all prior or contemporaneous understandings, agreements, or representations, whether oral or written.

Section 12 – Amendments

Any amendment or modification to this Agreement must be in writing and signed by both Parties.

Section 13 – Acknowledgements

The Parties acknowledge that they have read and understood this Agreement, have had the opportunity to seek independent legal advice, and enter into this Agreement voluntarily.

Section 14 – No Partnership or Agency

Nothing contained herein shall be deemed to create a partnership, joint venture, or agency relationship between the Parties.

Section 15 – Signatures; Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.
