## Agreement Terms:

### 1. Custody and Parenting Time Schedule:

The parents agree to share parenting time in a manner that is in the best interest of the child(ren). The schedule shall include weekdays, weekends, holidays, vacations, and special occasions. Parents shall cooperate to ensure timely exchanges and respect the child's routine and stability.

### 2. Transportation and Exchanges:

Transportation arrangements for parenting time exchanges shall be agreed upon by both parents. ### 7. Legal Compliance:

This Agreement is intended to be legally binding and enforceable under the laws of the United States. Parents acknowledge that they have had the opportunity to seek independent legal advice and enter this Agreement voluntarily.

8. Miscellaneous:

- a) Each parent agrees not to interfere with the other parent's time with the child(ren).
- b) Both parents shall provide emergency contact information and keep it current.
- c) Neither parent shall expose the child(ren) to harmful substances or environments during their parenting time.
- d) The child(ren)'s medical, educational, and other important records shall be available to both parents.

**9. Representations and Warranties**

Each parent represents and warrants that they have the legal right to enter into this Parenting Time Agreement and that doing so is in the best interest of the child(ren).

**10. Indemnification**

Each parent agrees to indemnify and hold harmless the other parent from any claims, demands, damages, or liabilities arising out of their respective actions during parenting time.

**11. Severability**

If any provision of this Agreement is found to be invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

**12. Entire Agreement**

This document constitutes the entire agreement between the parents regarding parenting time and supersedes all prior agreements or understandings.

**13. Execution**

This Agreement may be executed in counterparts and may be signed electronically or in writing, each of which shall be considered an original.

**14. Notices**

All notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail, or by electronic means with confirmation of receipt to the addresses provided herein.

**15. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_, without regard to conflict of law principles.

**16. Emergency Medical Care**

Each parent grants the other the right to authorize emergency medical treatment for the child(ren) during parenting time if the other parent cannot be reached.

**17. Travel**

Neither parent shall remove the child(ren) from the state or country for extended periods without the written consent of the other parent or court order.

**18. Confidentiality**

The terms of this Agreement and any disclosures made in connection with it shall remain confidential except as

required by law or court order.

**19. Parental Conduct**

Parents agree to refrain from exposing the child(ren) to conflict, disparagement, or inappropriate behavior related to the other parent.

**20. Child Support**

This Agreement does not address child support, which shall be governed separately by applicable laws or agreements.
