1. Authorization and Deduction

Employee hereby authorizes Employer to deduct from Employee's wages the amount specified above for the stated purpose. Employer shall remit the deducted amounts accordingly.

2. Duration and Termination

This authorization shall remain in effect until the total amount authorized to be deducted has been withheld or until Employee provides Employer with written notice of termination of this Agreement. Employer may terminate this Agreement upon written notice to Employee at any time.

3. Employee Representations

Employee represents that this authorization is voluntary and not induced by any representations other than those contained herein. Employee agrees that Employer shall have no liability for any delay or failure to make deductions.

4. Employer's Duties

Employer agrees to make deductions in accordance with this Agreement and applicable law, and to remit amounts deducted to the appropriate party or entity as specified by Employee.

5. Compliance with Law

Both parties agree to comply with all applicable federal, state, and local laws governing payroll deductions and wage withholding.

6. No Effect on Employment

This Agreement does not constitute a contract of employment or guarantee continued employment. Employee's employment remains at-will unless otherwise specified.

7. Indemnification

Employee agrees to indemnify and hold Employer harmless from any claims, demands, or liabilities arising out of or related to the deductions made pursuant to this Agreement.

8. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States and the state in which the Employer operates, without regard to conflict-of-law principles.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties regarding payroll deductions and supersedes all prior agreements or understandings, whether written or oral.

10. Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both Employee and Employer.

11. Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

12. Signatures

By signing below, Employee and Employer acknowledge and agree to the terms of this Payroll Deduction Agreement.
