Scope of Services:

Service Provider agrees to furnish pest control services (the “Services”) at the Client’s premises listed above. Services include inspection, treatment, monitoring, and follow-up visits as agreed. The Services will target pests including but not limited to rodents, insects, and other specified nuisances. Service Provider will comply with all applicable federal, state, and local laws.

Term of Agreement:

This Agreement shall commence upon execution and shall continue until either party provides written notice of termination at least 30 days in advance. Termination shall not relieve Client of payment for Services rendered through the termination date.

Payment Terms:

Client agrees to pay Service Provider the amounts invoiced for Services rendered, according to the agreed pricing schedule. Payments are due within 30 days of invoice date. Late payments shall accrue interest at the maximum rate permitted by law. Service Provider may suspend Services for non-payment.

Client Responsibilities:

Client shall provide reasonable access to the premises, remove or secure food and valuables as directed, and notify Service Provider of any conditions that might affect the safe performance of Services. Client shall follow any recommended preparation or follow-up instructions provided by Service Provider.

Warranties and Disclaimers:

Service Provider warrants that Services will be performed in a professional and workmanlike manner consistent with industry standards. EXCEPT AS EXPRESSLY SET FORTH, SERVICE PROVIDER DISCLAIMS ALL OTHER

WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. Results may vary due to factors outside Service Provider's control.

Limitation of Liability:

IN NO EVENT SHALL SERVICE PROVIDER BE LIABLE FOR INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING OUT OF OR RELATED TO THIS AGREEMENT OR SERVICES. SERVICE PROVIDER'S AGGREGATE LIABILITY SHALL NOT EXCEED THE AMOUNTS PAID BY CLIENT UNDER THIS AGREEMENT.

Indemnification:

Client agrees to indemnify, defend, and hold Service Provider harmless from any claims, damages, losses, or expenses arising from Client's breach of this Agreement or negligence, except to the extent caused by Service Provider's gross negligence or willful misconduct.

Compliance with Laws:

Each party agrees to comply with all applicable federal, state, and local laws, rules, and regulations in the performance of its obligations under this Agreement including, but not limited to, environmental and pesticide regulations.

Confidentiality:

The parties agree to keep confidential and not disclose to any third party any non-public information received in connection with this Agreement except as required by law or with prior written consent of the other party.

Force Majeure:

Neither party shall be liable or deemed in breach for any delay or failure to perform due to causes beyond reasonable control including acts of God, war, terrorism, strikes, government restrictions, or natural disasters.

Dispute Resolution:

The parties agree to attempt to resolve any disputes arising out of or relating to this Agreement through good faith negotiations. If unresolved, disputes shall be submitted to binding arbitration in the state of Client's address in accordance with the rules of the American Arbitration Association.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to its conflict of law principles. The parties consent to the exclusive jurisdiction and venue of state and federal courts located in _____ County, _____.

Entire Agreement:

This Agreement, including any attachments or schedules, constitutes the entire agreement between the parties and supersedes all prior understandings. Any amendments must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is found invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.
