Agreement Terms:

This Pet Agreement (“Agreement”) sets forth the terms and conditions under which the Owner entrusts the care and custody of the Pet described herein to the Caretaker. The parties agree to abide by the provisions set forth in this Agreement, which is legally binding and enforceable under United States law.

1. Caretaker’s Responsibilities

The Caretaker agrees to provide the Pet with food, water, shelter, exercise, grooming, companionship, and medical care as customary and necessary. Caretaker shall comply with all applicable laws, ordinances, and regulations relating to the care and treatment of the Pet.

2. Owner’s Responsibilities

The Owner shall provide all necessary supplies, instructions regarding the Pet’s care, medical history, and emergency contact information. The Owner shall promptly notify Caretaker of any changes in the Pet’s condition or care requirements.

3. Term and Termination

This Agreement shall commence on the date signed by both parties and continue until terminated by either party with written notice. Termination shall not release any party from obligations incurred prior to termination.

4. Veterinary Care

Caretaker shall seek veterinary care for the Pet in the event of illness or injury. Owner shall be responsible for all veterinary expenses unless otherwise agreed in writing.

5. Indemnification

Owner agrees to indemnify and hold Caretaker harmless from any liability, claims, damages, or expenses arising out of or relating to the Pet's behavior or condition, except in cases of Caretaker's gross negligence or willful misconduct.

6. Liability for Damages

Caretaker shall not be liable for any damage or injury caused by the Pet to persons or property, except in cases of Caretaker's gross negligence or willful misconduct.

7. Emergency Situations

Caretaker shall make reasonable efforts to contact Owner in any emergency. If Owner cannot be reached, Caretaker is authorized to take necessary actions to ensure the Pet's health and safety.

8. Access and Visitation

Owner shall have reasonable access to visit the Pet during the term of this Agreement upon prior coordination with the Caretaker.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles.

10. Entire Agreement

This Agreement constitutes the entire understanding between the parties regarding the subject matter herein and supersedes all prior discussions, negotiations, or agreements.

11. Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties.

12. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

13. Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of such provision or any other provision.
