Clause 1 – Grounds for Divorce

The parties agree that this divorce is uncontested and that the grounds for divorce are irreconcilable differences or no-fault grounds as allowed by the law of the state in which this Agreement is executed.

Clause 2 – Custody and Visitation

The parties agree on the custody and visitation arrangements for any minor children of the marriage, consistent with the best interests of the children. The custodial parent, visitation schedule, and any special provisions shall be detailed in a mutually agreed parenting plan attached hereto.

Clause 3 – Child Support

The parties agree on the amount and method of child support payments in accordance with applicable state guidelines and laws. Payments shall be made promptly and documented. Any modifications shall be agreed upon in writing and filed with the appropriate court.

Clause 4 – Spousal Support (Alimony)

The parties agree that spousal support is / is not applicable. If applicable, the amount, duration, and terms of spousal

support are as stated in this Agreement, and are consistent with applicable state laws.

Clause 5 – Division of Property and Debts

The parties agree on the equitable division of marital property and debts. A detailed list of all property (real, personal, financial) and debts, and the agreed division thereof, is attached as an Exhibit to this Agreement. Each party waives any claim to property or debts not listed or agreed.

Clause 6 – Retirement and Benefits

The parties acknowledge any rights to retirement benefits, pensions, or other employment-related benefits and agree to any division or waiver as detailed in this Agreement.

Clause 7 – Taxes

The parties agree on the filing status for tax purposes for the current and future tax years and on the responsibility for any tax liabilities or refunds related to the marriage and divorce.

Clause 8 – Mutual Release

Upon execution of this Agreement and final judgment of divorce, each party releases the other from any further claims, demands, actions, or liabilities arising from the marriage or its dissolution except as expressly provided herein.

Clause 9 – Legal Fees and Costs

Each party shall be responsible for his or her own legal fees and costs incurred in the negotiation and execution of this Agreement unless otherwise agreed and set forth herein.

Clause 10 – Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior agreements, negotiations, and understandings.

Clause 11 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the state in which the divorce is filed, without regard to conflict of law principles.

Clause 12 – Modification

Any modification of this Agreement shall be in writing and signed by both parties and approved by the court.

Clause 13 – Enforcement

This Agreement may be entered as a judgment and enforced by the court having jurisdiction over divorce matters in the appropriate venue.

Clause 14 – Acknowledgements

Each party acknowledges that he or she has carefully read this Agreement, understands its terms, has had the opportunity to consult with independent legal counsel, and enters into this Agreement voluntarily and without duress.

Clause 15 – Signatures and Execution

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument. Electronic signatures shall be deemed valid and binding.
