Section 1 – Grant of Rental

Lessor hereby rents to Lessee, and Lessee hereby rents from Lessor, the utility trailer described above subject to the terms and conditions set forth in this Agreement.

Section 2 – Rental Period and Extension

The Rental Period shall commence upon delivery or pickup of the trailer and shall continue for the duration specified above. Extensions of the rental period must be agreed upon in writing by both parties and may be subject to additional charges.

Section 3 – Rental Rate and Payment

Lessee agrees to pay Lessor the Rental Rate as specified above for the entire rental period. Payment shall be due in full prior to or upon delivery unless otherwise agreed. Any late payments or returned checks may incur additional fees.

Section 4 – Security Deposit

Lessee shall pay a Security Deposit as specified above. Lessor may use the Security Deposit to cover damages, unpaid rent, or other charges incurred under this Agreement. The Security Deposit, less any deductions, shall be returned to Lessee within a reasonable time after the rental period ends.

Section 5 – Use and Care of Trailer

Lessee agrees to use the trailer in a careful and lawful manner, in accordance with all applicable laws and regulations. Lessee shall not overload the trailer beyond its specified capacity and shall keep the trailer in good condition. Any damage, malfunction, or loss shall be reported to Lessor immediately.

Section 6 – Insurance and Liability

Lessee shall maintain adequate insurance coverage on the trailer during the rental period, including liability and physical damage coverage. Lessee assumes full responsibility for any damage, loss, or injury arising from use of the trailer. Lessor shall not be liable for any direct, indirect, incidental, or consequential damages.

Section 7 – Maintenance and Repairs

Lessor shall ensure the trailer is in good working order at the start of the rental. Lessee shall perform routine maintenance as necessary and shall bear the cost of repairs resulting from Lessee's misuse or negligence. Any repair exceeding \$___ requires prior authorization from Lessor.

Section 8 – Return of Trailer

Lessee shall return the trailer to Lessor at the agreed location in the same condition as received, normal wear and tear excepted, by the end of the rental period. Late returns may be subject to additional charges. Failure to return the trailer may result in fees, repossession, and legal action.

Section 9 – Indemnification

Lessee agrees to indemnify, defend, and hold harmless Lessor and its agents from any claims, damages, losses, liabilities, costs, or expenses arising out of Lessee's use of the trailer, including but not limited to claims for personal injury or property damage.

Section 10 – Default and Remedies

If Lessee defaults in payment or breaches any term of this Agreement, Lessor may terminate this Agreement, repossess the trailer, and pursue any legal remedies available. Lessee shall be liable for all costs incurred by Lessor in enforcing this Agreement.

Section 11 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising hereunder shall be subject to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Section 12 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect to the fullest extent permitted by law.

Section 13 – Entire Agreement

This Agreement constitutes the entire agreement between the parties relating to the rental of the trailer and supersedes all prior negotiations, representations, or agreements, whether written or oral. Amendments must be in writing and signed by both parties.

Section 14 – Notices

All notices required or permitted under this Agreement shall be in writing and delivered by hand, certified mail, overnight courier, or electronic means with confirmation of receipt, to the addresses set forth above or as updated by written notice.

Section 15 – Waiver

No waiver of any breach or default hereunder shall be deemed a waiver of any subsequent breach or default. The failure to enforce any provision shall not constitute a waiver of the provision or the right to enforce it.

Section 16 – Counterparts and Electronic Signatures

This Agreement may be executed in counterparts and may be signed electronically, each of which shall be deemed an original and all of which together constitute one binding agreement.
